Calendar

Archery Practice: Archer Marshal's House. If it's too cold for archery, indoor space will be available for projects. "Proceed down I-44 to exit 161 and turn south, you will take a right at the first light south of the freeway onto St Robert outer road and head east, you will travel approx 6 tenths of a mile and turn left which is south on the first road to the left which is Harlan, you will see a small church there on the corner and a big water tower, you will proceed about 5 tenths of a mile and make a right onto Hardin which is the second road to the right. you will go another half mile or so and pass the first road to the left which is Haskell and immediately after that there will be a large white house with pillars on your right and a trailer on your left...as you pass them there will be a lane to both right and left and a white fence starts up on the right..you want to take that unmarked lane to the left..you will go around 400 feet and top a rise and see my place nestled at the end of this short lane on the left."

Shire Meetings: Newburg United Methodist Church: Take I-44 to the Newburg Exit. Turn south. The church will be on your right, a little past the patrol car waiting at the bottom of the hill to catch all of you scoff-law speeders.

St Robert Community Center: Take I-44 to Exit 161. Turn towards Ft Wood (South). Immediately south of the highway, turn right. Take a quick left through the median and continue towards the Skate Board park. The Center is the big building near the radio tower.
